WHAT TO REPORT

Suspicion of (or direct knowledge of) abuse, neglect, exploitation, or violation of a resident's rights.

Abuse: threats to an elderly person's health and welfare

Neglect: failure to provide adequate food, shelter, clothing, medical care and personal care needs

Exploitation: misuse of money or property of an elder

Residents' Rights: In addition to freedom from all of the above categories: access to visitors and phone calls; freedom from physical and chemical restraints; right to contest a discharge or transfer from the facility; right to meet with legal representatives and the long-term care ombudsman; and access to personal and medical records

WHO CAN REPORT

Anyone can file a complaint. Some individuals (law enforcement, health care providers, social workers) are required to report.

Types of Care Facilities

Nursing Homes must be licensed by the State of Michigan. They provide skilled and basic nursing care.

Adult Foster Care Homes (AFC) must also be state licensed. They provide 24-hour supervision, personal care and protection for up to 20 residents.

Homes for the Aged (HFA) must be licensed by the state. They provide supervised personal care in addition to room and meals for persons age 55 and older in a larger setting than an AFC home.

Assisted Living Facilities are not a licensed category. If they provide AFC or HFA levels of care for their residents they must be licensed. Other assisted living facilities provide laundry, housekeeping, and meals, but do not directly provide personal care or supervision. Residents may contract with a home care agency or an individual for services such as medication management, help with bathing and dressing as well as mobility needs.

Room and Board Homes are not licensed. Supervision is not provided as residents must be independent with all daily living tasks.
